Dear Prospective School Board Candidate:

Candidates for the Board of Education must be at least 18 years old; qualified voters in the school district; able to read & write; and must be residents of the district continuously for one year before the election. They can't be employees of the school district or live in the same household with a family member who is also a member of the same school board.

Attached hereto are three copies of a Nominating Petition for your candidacy. Nothing in the Education Law specifies the earliest date that candidates may begin collecting signatures on nominating petitions, however, the closing date and time is established in accordance with NYS Law (EDN 2608.1). The filing deadline in small city school districts is on or before the twentieth day preceding the election. For the **May 18, 2010 election** in the Greater Johnstown School District, **petitions must be received in the Office of the Clerk of the Board of Education at 1 Sir Bills Circle, Suite 101 (JHS) by 5:00 PM on Wednesday, April 28, 2010.** It is recommended that you not wait until the last day to file.

The signatures of one hundred qualified district voters are required, but it is recommended that additional signatures be obtained, in case any are invalidated for some reason. A qualified voter is a citizen of the US, at least 18 years old and a resident of the school district for at least 30 days immediately prior to the election. A person need not be a registered voter to satisfy the legal definition of a qualified voter for purposes of signing a school board nominating petition. Generally, there is not a limit as to the number of nominating petitions a qualified voter may sign in a school district election. All persons must sign their name and note their address. Printed signatures are not valid.

A drawing to determine the position of candidates' names on the ballot will be conducted in the District Clerk's Office on **Thursday, April 29, 2010 at 1:00 PM**; candidates or their designated proxies may attend. The District Clerk will act as proxy for any candidate who is not present and hasn't designated a proxy in writing.

Candidate's Night (sponsored by the Central Council of the Parent/Teacher's Association) is a forum for citizen awareness of candidates, issues and positions. Candidates Night *may* be held in conjunction with the Public Budget Hearing scheduled for **May 4, 2010 at 6:30 p.m.** at Johnstown High School. Additional information about Candidate's Night will be provided when available.

Finally, please note that, pursuant to NYS Education Law §1529, School Board candidates are required to file campaign contribution & expense statements. Further information regarding this requirement is available on the District web site, [www.johnstownschoools.org](http://www.johnstownschoools.org), or may be obtained from the District Office.
