Summary and Background Information

On March 11, 2021, the President signed into law the American Rescue Plan Act of 2021 (ARP). ARP makes available \$122.8 billion nationally in a third round of Elementary and Secondary School Emergency Relief (ESSER) funds. New York State has been allocated nearly \$9 billion under the ARP Act's Elementary and Secondary School Emergency Relief (ESSER) Fund.

The federal ARP statute requires that States reserve ARP ESSER funds for three State-level reservations for evidence-based activities and interventions that respond to students' social, emotional, mental health, and academic needs and address the disproportionate impact of COVID-19 on students from low-income families, students of color, English learners, children with disabilities, students experiencing homelessness, children and youth in foster care, and migratory students.

Not less than 5 percent of the State's grant must be reserved to carry out, directly or through subgrants or contracts, activities to address the academic impact of lost instructional time by supporting the implementation of evidence-based interventions.

Not less than 1 percent of the State's grant must be reserved to carry out, directly or through subgrants or contracts, the implementation of evidence-based summer enrichment programs.

Not less than 1 percent of the State's grant must be reserved to carry out, directly or through subgrants or contracts, the implementation of evidence-based comprehensive after-school programs.

The 2021-2022 enacted New York State budget fully allocated the required SEA reserves as subgrants to 398 LEAs and NYSED has made allocations to two additional LEAs. The LEA completed a needs assessment based on the process for schools in need of improvement from NYSED. We used the information from stakeholder interviews, DEI assessments, data review in the following areas: academic, attendance, SEL, and behavior to determine the most significant needs of our students based on the pandemic. From there our stakeholder team reviewed "How Learning Happens" and the resources provided by NYSED for addressing learning loss to align interventions for this funding.

The District will coordinate the use of all ARP funds to address the impacts associated with lost instructional time. The district will use the funds it reserves under section 2001(e)(1) - to address the academic impact of lost instructional time through the implementation of the following:

- Additional AIS providers one at each building to support ELA and Math Tier II and III interventions for students most at risk (Funding sources: Title IA funding, ARP, CRRSA)
- Community Outreach Specialist will be utilized to connect with families and their student(s) to ensure a strong home to school connection exists and any barriers to attending school and learning are removed. (Funding source: ARP)
- Instructional coaching at all three buildings to support educators with research-based practices to meet the needs of all learners in the classroom.

 Coaches will also support family engagement programs. (Funding source: CRRSA, ARP and LEA General Fund)
- The district is working with community based organizations to develop a comprehensive after-school program to support K-12 families (Funding Source: ARP, state reserve for after-school)
- The district will enhance our tutoring program and offer additional supports for students who are falling behind academically or need additional support outside of the school day (Funding Source: State reserve for after-school)
- The district will develop a comprehensive after-school Regents prep program for 9-12 students (Funding Source: ARP and State reserve for after-school)
- The district will also be hosting a K-8 summer learning/enrichment program each year of the grant. (Funding Source: state reserve for summer programming)
- The district will invest additional funds to allow for two full-day UPK programs to run during the entire grant period. (Funding source: ARP)
