 - Read "What's Behind the Ban on Cell Phones in K-12 Schools?"
 - Addiction, isolation, neglect
 - Big Tech is driving the addiction for profit
 - 24 hour on-demand entertainment; mindlessness and lack of rest in the old days, tv programming shut down
 - Mental health crisis is largely impacted by phones
 - Intention of phones (parental contact) is not the reality of the cell phone usage.
 - Anxiety level of everage kid today comparable to anxiety of a kid in the '50s who would have been hospitalized
 - Happiness and joy matters; no matter what our students choose, we want them to be happy; "...experience joy in a conversation"--from article
